Dear Mrs. Perea:

In compliance with subsection 5.2.4.1.5 of Decree 2555/2010 as to the obligation to report relevant information, we hereby inform your Office of the occurrence and formalization of an early liquidation event of the TIPS Pesos N-6 issue. In this regard, as of this date we have fulfilled the requirements defined in the Rules of Issue of TIPS Pesos N-6 (the "Rules") for this event as follows:

1. It has been established as per the provisions of the Rules that an early liquidation event occurred because the total principal balance of mortgage loans on the payment date is equal to or less than 5.0% of the total principal balance of mortgage loans on the issue date (August 23<sup>rd</sup>, 2012). Said percentage is equal to 4.90% as described below:

2. In compliance with the provisions of subsection 12.3.1 of the Rules, the early liquidation event of TIPS Pesos N-6 issue was formalized on February 23<sup>rd</sup>, 2022 by letter submitted to Helm Fiduciaria Itaú Fiduciaria S.A. (formerly Helm Fiduciaria) in its capacity as Bondholder's Legal Representative in the TIPS Pesos N-6 Issue informing thereby the occurrence of the early liquidation event.



Based on the powers granted in the Rules to the Titularizadora Colombiana to accomplish early liquidation process, we hereby inform your Office that today will be perfected the sale of the mortgage loans of the TIPS Pesos N-6 Issue in development of the purchase and sale agreements dated February 16<sup>th</sup>, 2022 signed with Davivienda and BBVA Banks, as we previously reported through our relevant information report dated February 16<sup>th</sup>, 2022.

Payments to the TIPS Pesos N-6 Class B and MZ for early settlement will be made as of February 23<sup>rd</sup>, 2022.

We remain at your disposal to provide any additional information that may be required.
